### Photography

#### (Use of student photographs/personal information)

Anyone with the Internet is able to access these pages from virtually anywhere in the world.

Student photos are sometimes posted on the division's website or a school website to showcase particular events or activities. If included, identification would be done by **first name and first initial of last name only**. Photos of large groups, or action photos where students cannot be identified, may be posted without parental permission.

Personal information may be used to recognize student accomplishments or participation in academic or extra-curricular activities. Only a student's **first name and first initial of last name** will be used.
